Rider agrees not to take legal action against them on account of or in connection with any claims, causes of acting, injuries, damages, costs or expenses. Including without limitations those based on death, bodily injury, property damage, and consequential death arising out of riders use or presence on Serenity Show Stables.

Rider agrees to assume any and all risks involved in and arising from rider's use or presence upon "SSS" property and facilities including, but not limited to the risks of death, bodily injury and property damage resulting from falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire or explosion, the unavailability of emergency medical care, or negligence or deliberate act of another person.

If a rider is using their own horse, the horse shall be free from infection, contagious or transmittable diseases. "SSS" reserves the right to refuse a horse if it is not in proper health or is deemed dangerous or otherwise undesirable.

### **Serenity Show Stables Rules and Regulations**

- 1) All riders MUST wear ASTM/SEI Certified helmets while mounted.
- 2) No minors shall be allowed on the premises at any time without an adult present.
- 3) Adult riders who own their own horses are strongly urged to have another adult present in the absence of an instructor.
- 4) Riders may not be mounted inside the barn area or on the wash racks.
- 5) Riding must be confined to the ring, round pen or grass field. Horse owners assume full responsibility for any and all riding off premise.
- 6) No jumping shall be allowed without an instructor present.
- 7) Keep all common areas ( wash racks, breezeway, bathrooms, etc.) clean and free of debris at all times. Keep areas in front of stalls picked up and organized.
- 8) Parents dropping off children must receive consent from the instructor prior to doing so, as well as provide "SSS" with a copy of their medical insurance card and a signed consent letter allowing "SSS" instructors to act as guardians in the event of an accident where medical attention is required and the parent cannot be reached.
- 9) Dogs are not allowed on the premises. Service animals are to be kept on a leash at all times.
- 10) Social media posts are welcomed and encouraged; however, any audio clips where trainers can be heard giving instruction must be removed. Any person found posting on social media or in group chats negative or derogatory comments towards ANY other rider will be immediately asked to leave. "SSS " has a ZERO tolerance policy in regards to bullying of any kind.
